Also the login for Hummingbird has been changed to yvonpappy@gmail.com the password remains the same. Produce is ordered from Organically Grown October thru June. I will be sending out the information from Organically Grown as soon as I receive it. If you see something you would like to order from Organically Grown, you'll need to order the item, (the last pages 8, and 9 are for small buying clubs) find interested people to split it with, pay for it, and split it among yourselves. If you are interested or have questions about Organically Grown produce, I'll be happy to find out before the deadline.

Food distribution will still be at Denise and Chuck's house, as the Azure delivery is sometimes on a different day as the Eugene orders.

#### Annual Deadwood Food Co-op Meeting January 8, 2023

The meeting started at 1:00 PM, in attendance were: Greg K, Nancy R, Tchanan R, Bill C, Denice H, Michelle H, Mary Lou R, Sandy, Jan K and Yvonne P

1. Discussion & clarification of Volunteer Compensation:

Nancy explained the current compensation rates for drivers, distribution break-down, bookkeeper, and food co-ordinator, which is credited towards their food order. Bill looked up the federal mileage rate, which is 65.5 cents per mile. There was some discussion about being paid for the time in town besides mileage. This was followed by a discussion of what a co-op is- "group of people who come together voluntarily to meet a common goal" ours being the purchase of bulk food that is organically grown.

Compensation: Federal mileage rate of 65.5 cents per mile will be used for drivers from home to Eugene and back, and will be used through December 2023.

2. Change ordering to even months instead of odd months.

The group wanted to keep the odd months, there won't be any changes.

- Ordering check balances with Yvonne for: Money owed or credits due to items not in stock. Yvonne mentioned it is important to mention the product size such as 6 x 16 oz. when ordering. Neither Azure or Hummingbird have the ability to look up an item by their product number.
- 4. Change in Order Form who would like to take this on? No one volunteered.
- 5. Do we want to stay with Azure or look at United Natural Foods? After people expressing concerns about pricing from Azure they felt they could get a better price at various markets. Yvonne mentioned she sends out 39 emails but there is a small core of people that order (approximately 11 families) and only one family under the age of 40 that orders. Jan asked the group do we really want to continue the Deadwood Food Co-op. This group has been together since the mid 70's and it is hard to visualize the end of the Co-op. It was suggested we revisit the continuation of the Deadwood Food Co-op at the next Annual Meeting. It was mentioned the group use to order from United Natural Foods out of Rockland CA. Yvonne offered to contact them and see about minimum ordering and pickups in Mapleton. Submitted by Yvonne Pappagallo

I was visited by many Doctors and staff who had any number of very professional positions. My secondary family became very large.

To this special community, Sacred Heart Medical Center at RiverBend I say with a deep sense of appreciation and respect, "Thank You". It is so little for me to say for those who gave so much to me and my immediate family.

You are there today as you were all those yesterdays. You will continue to be there for everyone tomorrow and beyond. Through all of the harder stuff you prevail.

- I. Archive Project:
  - Kate: Interested in the possibility of an oral history project of the community center
  - UofO maintains some archive of Ditto;
  - Videographer connection? Possible video history
  - Seek funding for expenses/time?
  - The board supports Kate with researching more options/info and will discuss at next meeting.
- II. Grant Updates:
  - Western Lane Community Foundation opens 3/15-5/15
  - Ford Family Foundation Grant can be submitted at any time
    - Courtney will bring options for grant funding to March meeting so we can prioritize needs and funding choices after playground meeting
- III. Internet
  - Ami sees internet as public utility; would provide education options for community and technical trainings (internet safety, setting up & using Gsuite/Gmail, etc.); Sees need for coworking space in community for employment - possibility to meet with date/babysitting options during the week when Center is usually empty

- Mary - daytime use is low; past concerns - space not being respected, people taking advantage of it too much, camping out/living there; liability concerns Implementation Discussions:

- Modem can be shut down at certain times (Third Saturdays or overnight) could be checked out for events/specific purposes
- Try it for 6 months/1 year and revisit use/cost

- What options do we have for providers? Cost? Grant funding options via education/emergency preparedness/community reconnection focuses?
  - Generally, community is underserved with internet access and many have insufficient upload speeds to meet their needs
- Courtney Should we ask for community input and are there processes we've used in the past? Have heard many discussions at Annual Meetings & informally
  need to look for funding options in order to implement with community support and discuss implementation specifics Courtney will research
- Board Consensus: In agreement with implementing internet access but will talk about how to do so when the full board is present and we have more information on financial/funding details

#### IV. Playground

- structure options Burke is the main supplier for equipment; do want to pay for installation?; Trying to gauge how much of the grant funding would be used for installation but feel strongly that should be professionally installed for safety reasons;
- Ami is getting in touch with representative to set up a site visit
- Gazebo more than we could do with the resources (budget/volunteers) we had last year;
  - In the past, hired local people to install the big patio at the Center look at how bylaws specify employment rules/contracts for projects at Center
- V. Bylaws Review -

- Make/send out copies for everyone; review before next meeting to ensure it is meeting current needs and we are clear on limitations/expectations

VI. Financials

- Do not have DCS debit card currently; Maggie will ask Banner about whether we have debit card available.

- Release of Liability - needs to be signed by all volunteers and contractors so that we're covered in case of accidents and do not need to pay for additional umbrella insurance

- VII. Building Repairs/Maintenance:
  - Outhouse base looks rotted, take roof off, build a new base for the roof? Mary will ask Jay for a materials list for an outhouse repair so we can quote cost
  - Purchase stopper for kitchen sink Courtney
  - Mary check in w/ stove setup and ensure it's working as expected
- VIII. Event Promotion Process -

Kate: would be helpful to clarify the workflow for promotion

- Deadwoodcreekservices.com Ami owns and hosts on his larger platform for free; is currently a great venue for online donations and has many other capacities but need to determine intentions for use
- Deadwoodtradingpost.com Carl Logan is the one currently hosting and has all archival Ditto information; will wait to see billing cost/options

- Ami shared login information for Gmail account and will set up email list so that people can sign up for event updates through the website (actually, Ami, I'm not sure this is where we landed officially - sorry, was this where we needed to pay for an email account?)
- IX. Third Saturday -
  - Generally covered with potluck setup, appreciate any help to prepare the space
  - Board members support as they're able
- X. Communication:
