Hello Deadwood Community members,

As the District Ranger of the Central Coast Ranger District on the Siuslaw National Forest, I'd like to express my gratitude for the warm welcome from the community at the public meeting in June about the Deadwood Creek Restoration Project. I very much appreciate the interest, engagement, and ideas that folks put forth about the project and I'm wondering what the next steps should be to keep the momentum going.

As a reminder, the overall purpose of this project is very similar to the watershed-scale restoration projects that the Siuslaw National Forest has been doing for several decades now, which typically include restoration and enhancement of fish and wildlife habitat. Similar projects in the past have included activities such as noxious weed removal; thinning young, dense, planted forested areas in order to accelerate the development of wildlife habitat as well as to provide commercial timber products; replacing undersized culverts with structures that fish are able to pass through; decommissioning old logging roads that are causing resource damage and are no longer needed; and arranging wood and logs in streams to create fish habitat.

We're still pretty early on in thinking about this project and I'm hoping to continue to get input from you to ensure we develop an ecologically and economically sound project together. To that end, it would be very helpful to hear from you about a few things: would you prefer another meeting or a field trip? What times and dates in August would work best? And are there particular topics you'd like to discuss?
