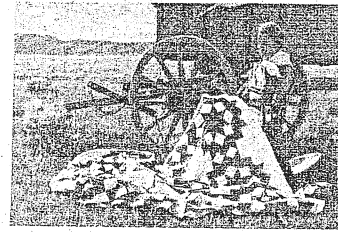

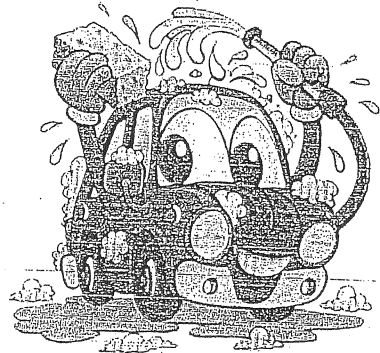

We would like to express our gratitude for everyone who took the time to email, call or attend a meeting regarding our Waste Management services this summer.

The feedback we received had a direct and clear effect on the recommendations that the Board of County Commissioners will be voting on within the next few weeks. We solicited comments, questions and concerns from the 200 people that attended our public input meetings across the county, read more than 150 emails, received dozens of phone calls and heard from community members during public comment at Board meetings. That feedback drove commissioners and staff to look for a solution that mitigated those concerns and still allowed us to make progress creating long-term financial stability.

The Board held a work session on Wednesday and - after public comment from Springfield Mayor Christine Lundberg, commercial haulers and community members - evaluated the merits of a recommendation that combined the consultant's work with the concerns shared by the community.

The Board ended the meeting by directing staff to return to an upcoming regular Board meeting with action items to be put to a formal vote.

The items returning to the Board for a vote are:

- Keeping all transfer stations open, except Mapleton
- Reducing hours at the McKenzie Bridge and Swisshome transfer stations to Saturdays only
- Excluding commercially hauled compacted waste from the Glenwood transfer station, which will also reduce traffic, noise and odor in an area slated for significant development in the coming years
- Increasing the tonnage fee at all sites except Short Mountain Landfill from \$76.77 to \$80.00
- Increasing the four most commonly used self-haul rates by a range of \$1.00 to \$2.50

If formally approved by the Board, we expect to close the Mapleton transfer station and reduce hours at McKenzie Bridge and Swisshome on October 1, 2016. The self-haul fee adjustments would take effect before the end of the year. The exclusion of commercial haulers from Glenwood and the increase in tonnage fees would not be expected to occur prior to July 1, 2017.

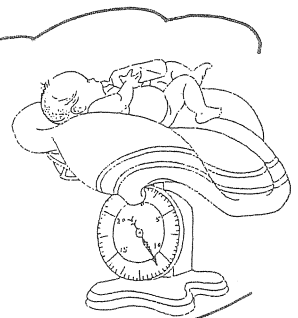

Lane County Waste Management - Recommended Option  
August 16, 2016

Recommendation:

1. Increase fees on the four most commonly used self-haul rates:

| Fee Type                           | Current Rate | Proposed Rate |
|------------------------------------|--------------|---------------|
| Up to 1 cubic yard                 | \$10.00      | \$12.00       |
| 1 cubic yard to 3 cubic yards      | \$17.75      | \$20.00       |
| Each cubic yard over 3 cubic yards | \$9.00       | \$10.00       |
| Demolition                         | \$12.50      | \$15.00       |

Annual revenue: \$410,000

2. Maintain current fee for tonnage received directly at the landfill. Increase tonnage fee at other sites from current rate (\$76.77) to \$80.00:

Annual revenue: \$140,000

3. Exclude Commercially Hauled Compacted Waste from the Glenwood Transfer Station:

Annual savings: \$510,000

4. Keep all transfer stations open, except Mapleton:

- Mapleton is the least utilized site in the system – averaging less than 10 paying customers per week.
- It is the most budget imbalanced site – expenses exceed revenues by -\$247/ton.
- It has an exceedingly small service area (113 square miles) – roughly 1/10<sup>th</sup> of the state average.
- The area is serviced by a commercial hauler and there are three other transfer stations in relatively close proximity (Florence, Walton, and Swisshome).

Annual savings: \$36,000

5. Reduce hours at the McKenzie Bridge and Swisshome Transfer Stations to become Saturday-only sites

- Both sites have similar customer counts as the London Transfer Station which operates effectively as a Saturday-only site.
- Both sites average less than 12 paying customers on week days that they are currently open.
- Half of the McKenzie Bridge tonnage comes from a commercial hauler. The site would remain accessible to the commercial hauler on specified week days.

Annual savings: \$14,000

Total budget closure: \$1,110,000

# Lane County Seeks Input on Regional Solid Waste Management Plan to Reduce Waste

Lane County's Waste Management Division is seeking public input on its update to the regional Solid Waste Management Plan, including potential strategies to increase waste diversion from the landfill.

The ultimate goal of the updated management plan is to develop a waste management system that is environmentally sound, technologically feasible, cost-effective, locally controlled and publicly acceptable, while providing for an overall reduction in waste generation. There are two ways for community members to provide feedback:

- Attend one of three community meetings:
  - o Monday, September 19, 6:00 p.m.–7:30 p.m., Atrium Building Lobby (99 W. 10th Avenue, Eugene)
  - o Tuesday, September 20, 6:00 p.m.–7:30 p.m., Florence Events Center (715 Quince Street, Florence)
  - o Wednesday, September 21, 6:00 p.m.–7:30 p.m., Creswell Community Center (99 S. 1st Street, Creswell)

Each meeting will include an open house from 5:00 p.m. to 6:00 p.m. with information for those who are unfamiliar with the detailed of Lane County's regional solid waste systems.

In addition to the community meetings, Lane County will reach out to city representatives, those in the solid waste industry and business leaders.

“Working with our community to create a long-term plan to reduce our collective waste and manage what remains is critical to a healthy future,” said Waste Management Division Manager Dan Hurley. “An updated plan will help us create long-term stability in our services, help us protect our environment and support a healthy economy.”

The current Solid Waste Management Plan was adopted in 2002. Lane County has since achieved the majority of the goals outlined in that plan. In addition, there have been significant changes in solid waste management technology and laws during the last thirteen years.

Lane County has set a targeted, countywide recovery rate of 63 percent by the year 2050. In 2014, the recovery rate was 53.1 percent. To reach its goal of a 63 percent recovery rate, the County will need to divert approximately 49,000 additional tons each year.

This update is a cooperative effort among citizens, local governments, and private industry stakeholders to develop an effective Solid Waste Master Plan that will guide regional efforts through 2030. It is an opportunity to seek new and innovative solutions and partnerships that will support a healthier community.

# Lane County takes on management of State's Konnie Park near Siuslaw River

Lane County's Parks Department will begin operating and maintaining Konnie Memorial Park as part of a 25-year lease with Oregon Department of Fish and Wildlife (ODFW).

Konnie Memorial Park is a 145-acre property with a popular boat ramp and day-use area near Swisshome along Lake Creek at the confluence of the Siuslaw River.

"Operating Konnie Memorial Park is a great partnership for Lane County and the State," said Parks Manager Mike Russell. "We currently maintain other parks in the area and will be able to ensure Konnie Park is maintained as a popular destination for fishing and picnickers."

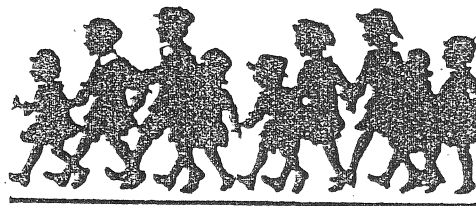
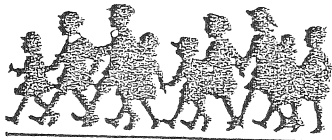
In recent months, park neighbors have shared concerns about security issues and illegal use of the park. Lane County Parks will work to establish a volunteer park host, who will live on-site, to improve security and provide minor maintenance.

The lease agreement does not include a financial agreement between Lane County and ODFW. It does allow Lane County to charge a parking fee consistent with other County-operated parks and to make improvements to the property.

Lane County Parks has similar agreements in place with ODFW for other parks, including Mapleton and Tieman boat landings.

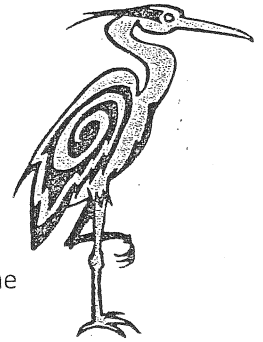
**MAPLETON SCHOOL DISTRICT ANNOUNCES SUCCESSFUL SALE OF 2016 GENERAL OBLIGATION BONDS;  
LOWER LEVY RATE**

MAPLETON – Mapleton School District is pleased to announce the successful sale of \$4 million in general obligation bonds, which was approved by voters in May 2016. The sale was well-received by investors.

The District sold \$4 million in bonds but will receive slightly more –\$ 4,102,783. The additional revenue comes from premium bonds. “In this low interest rate environment, investors were willing to pay more than 100 cents on the dollar to purchase our bonds,” said Maria McEldowney, the District’s business manager. Like the \$4 million match grant from Oregon Department of Education, this additional revenue will be used to further invest in facilities.

Thanks to strong investor reception and favorable interest rates, total principal and interest costs for the sale are significantly lower than preliminary estimates. The bond levy rate will be approximately \$1.31 per \$1,000 of assessed value. This is considerably less than the preliminary rate of \$1.59 previously discussed. “We are delighted with the results. The voters in the Mapleton School District overwhelmingly supported the bond. To be able to provide them with a lower than expected bond levy rate is very exciting,” said Jodi O’Mara, the District’s superintendent. The District worked with Piper Jaffray’s Seattle-Northwest Division as the underwriter for the bond sale.

Bond funds will be used to improve school facilities, support, student learning, and address safety and security at Mapleton Elementary (1957) and Mapleton High School (1948). The majority of construction work will begin in the summer of 2017.
