At the Dec. 19th County

Commissioner's meeting, residents of Lane County filled Harris Hall in protest of County Counsel Steven Dingle's decision to take the Freedom from Aerial Herbicide Alliance (FAHA) charter amendment off the May ballot. This initiative had already been given the green light after satisfying the "single subject" and "full text" rules. Not only has Mr. Dingle created a new obstacle for the petitioners, he won't explain why the measure doesn't comply with the "separate vote" rule ...!?

Under the constitution and related case law, the single-subject rule means that an initiative must pertain to one subject and matters properly connected. "Matters" are not separate subjects, but can be diverse issues that are properly relevant to a law addressing the single subject. For example, to recognize rights and prohibitions to stop aerial spraying of herbicides (the single subject) under the current system, you must also authorize the people's lawmaking authority to enact and enforce such rights and prohibitions, and stop corporations from exercising corporate personhood rights to overrule the rights and prohibitions. This rule was expressly adopted to prevent log-rolling where legislation is introduced which includes multiple different laws combined into one bill. For example, a law is proposed to fund children's health insurance, and because legislators expect this bill to pass easily, they stick in another part that would grant enhanced rights to own a gun.

The separate-vote rule is more strict than the single-subject rule, and to date has only applied to state constitutional amendments. It requires that any proposed amendment that makes two or more substantive changes to the existing constitution that are not closely related to be voted on separately by the electorate.

It is important to note that Judge Rasmussen did not require this constitutional rule to apply to proposed charter amendments in Lane County, even though the County has chosen to interpret it that way. And indeed, Dingle publicly stated that Rasmussen ordered this rule.

The language from the constitution enforces the separate-vote rule on proposed constitutional amendments and nothing more.

The statute does not include any language that directs the County Clerk to enforce this rule, how to appeal her review, etc. That is why Rasmussen found that the statute is not self-executing. This is in contrast to the statute that directs the clerk to enforce the single-subject and full-text rules, which is why the County "borrowed" the procedural language from this other statute. The county can't do this without violating the separation of powers; they don't get to make up the law.

.This and other hurdles are progressively eroding the people's lawmaking power to the point where it becomes almost impossible to address any serious policy issues facing the public. The initiative system is how "We the People" legislate. When our representatives are deaf to our pleas, we turn to the initiative system for action. We understand that the initiative process is arduous and requires dedicated and committed petitioners, but these rules, designed to limit legislative abuses, end up hampering legitimate and highly needed legislative reforms such as the spray ban that enjoys broad support from the public. FAHA is a shining example of a dedicated group of county residents who complied, in good faith, with every requirement of this difficult undertaking. Lane County voters expect the same dedication to "rule-following" of the elected and appointed gate-keepers of the people's initiative system. We demand it. We have the constitutional right to expect that county officials will play by stipulated rules and not change those rules in the middle of the game. Lane County residents, outraged by the stonewalling of the People's process by the County Counsel, insist upon transparency and accountability. We the People view the initiative process as sacred. Our fore-parents fought long and hard to establish this method of law-making and we have the honor and responsibility to maintain the integrity of the people's right to legislate in this manner. Our county commissioners share this responsibility.

County officials should recognize that there is a palpable sentiment within the community that FAHA's initiative addresses a critical need, and rather than hindering progress, their role in the process should be to meet the needs of the people. That means being constructive and transparent about how it applies any legal requirements.

We anticipate that another county initiative, the Right to Local Community Self-government, will likely be subjected to the same separate-vote review. This initiative, sponsored by Our Community Our Rights, is meant to accompany the spray ban and will grant county residents the legal authority to write and pass laws, like the spray ban, that protect our health, safety and welfare. And while we dispute that such a review is legal or constitutional, we nevertheless expect a full explanation of any approval or denial of that initiative's compliance with the rule.

The most recent slap in the people's collective face has just been revealed:

On December 21, in the law suit filed by the spray ban initiative's chief petitioners challenging the Clerk's determination, Dingle blew off the deadline to explain its position and instead relies on the filing of Intervenor Stanton Long - advocating the timber industry's interests - to answer for our local government's own actions to stop this initiative. Instead of answering to the voters for the County's actions, Lane County - through Mr. Dingle - is leaving it to the timber industry provide that explanation. This in itself, is outrageous! We the People of Lane County, insist that our Commissioners are held accountable for this obvious and negligent malfunction of our local government's stewardship of the people's initiative process. We demand action and remedy. As we have been faithful to the process all along, it is the voter of Lane County who have the right to decide if the spraying of toxic chemicals from helicopters on our forest lands will continue or be banned.

SIUSLAW VISION RECEIVES GRANT FOR \$280,000, ANNOUNCES THREE CONTRACTED POSITIONS OPENING

Siuslaw Vision 2025 is pleased to announce it has received a \$280,000 grant to support implementation of the Siuslaw Vision for 2018-2020. The award includes funding for three new contracted positions, including a Vision Coordinator, Information Technology Support for the Vision, and an Administrative Assistant. The overall purpose of the grant is to sustain progress on Siuslaw Vision initiatives, including the new community calendar and website at RiverCal.org, and to leverage community-led action in the Siuslaw region.

Susy Lacer, who served as part-time Vision Coordinator during 2017, is excited about the award and what it means for the region. "This not only represents sustained funding for the next three years of the Siuslaw Vision, it means we have some resources to support Vision initiatives that serve our local residents. Also, this funding helps meet one of the Vision's biggest goals: creating living wage work opportunities in the Siuslaw."

Overseeing implementation of the ten-year Siuslaw Vision is the responsibility of a volunteer steering committee, the Vision Keepers, together with an Advisory Committee that serves as a resource guide. The Vision Keepers, in collaboration with the Siuslaw Public Library District, which serves in the capacity of fiscal sponsor for grant funds, have worked closely with the Ford Institute for Community Building throughout the creation and implementation of this community vision project. The combined efforts of many local volunteers, organizations, and agencies are seeing success in accomplishing Vision initiatives, to the benefit of all Siuslaw residents.
