Normally we would be gearing up for our big Annual Meeting. However, true to the new reality of 2020, things are a little different this year...

We are writing this letter as a precursor to the Annual Meeting.

We hope to answer a few questions and offer updates on the following topics:

-Availability of the Community Center Building and Grounds.-Play Ground Project.-Annual Meeting.-Fundraising.

#### IS THE COMMUNITY CENTER AVAILABLE?

There have been a number of inquiries about the possibility of reopening the CC, as well as requests to rent the facilities. This has been a difficult and ongoing topic of conversation. The CC hosts so many wonderful yearly events and has been a vital gathering place for this community. We appreciate the desire to have it reopen, unfortunately we cannot safely and responsibly do it at this time. The Deadwood Creek Services (DCS) Board carries the insurance for the CC. In order to continue to receive coverage, we must comply with the Statewide Reopening Guidelines. If we do not comply, we could be liable for any accidents, injuries, or damage.

We will continue to revisit this decision as we move forward. We acknowledge how strange it may feel to have the CC closed, as it has been unlocked and available for so long. Thank you for your patience with us as we continue to navigate through this very strange moment in history.

# WHAT'S UP WITH THE PLAYGROUND PROJECT?

In the past 6 years the number of youth in Deadwood has increased significantly. We felt it prudent to update the CC to support the inclusion of these community members. Some of the existing playground had become dilapidated to the point that it was no longer safe for kids to play on. Last November at the Annual meeting we presented a plan to the community to update the playground. We began applying for grants for this project and in the spring we received a \$5000 grant from Western Lane Community Foundation.

The project began with the removal of some of the old structures. We have built a fence and will be adding some gates to define the playground area. The old Rocket play structure has been beautifully refurbished! We have begun preparing for the construction of a new swing set. We will also be creating paths and new outdoor seating areas. We hope this fosters an even more family friendly environment and creates more opportunity for gathering (when that feels appropriate).

Thank you to all the community members who have volunteered their time to help. If you are interested in helping with this project, please contact any member of the Board.

## WHY CHANGE THE TIMING OF THE ANNUAL MEETING?

Our tax year has shifted to begin on January 1 and end on December 31. (Before it ran November 1- October 31). Therefore, we will not be able to give an accurate Annual Financial Report until after January 1. This, combined with the fact that we need time to work out the logistics of such a large gathering, instigated our decision to postpone the Annual Meeting until mid-January 2021. We will keep you posted.

#### FUNDRAISING

Even though the CC is currently closed, we are committed to maintaining and improving it for when it will reopen. The CC has been such a valuable asset to our community, and it will continue to be for years to come. This year, the income for Deadwood Creek Services (DCS) has been significantly reduced by the absence of 3rd Saturdays and the lack of rental fees. Yet, we still have bills to pay, taxes to do, and improvements to invest in. We would be ever so grateful for you to consider making a donation.

## Internet Access Opportunities This could be very important to you!

Did you receive a letter from James Rennard the GM of Pioneer Connect? Did you toss it aside like I did? If you did, we both might have made a big mistake! It sounds as if we have a great opportunity to improve the internet service to every home and business from T-Lake to Deadwood areas. Having greatly improved internet service could enhance our rural community's opportunities to survive into the future via distance learning, telehealth, working remotely, running a small business, or many other ways of enhancing our lives......, some of which haven't even been imagined.

The federal government is providing financial support to rural communities through the Community Connect Grant Program for underserved rural areas. FTTH, fiber-to-the-home, is universally recognized as the gold standard in network construction. We have an opportunity to get this future-proof network to all 375 homes in our neighborhood.

## **Open Letter to the Deadwood Community:**

Pioneer Connect is applying for a USDA's Community Connect Grant Program to bring fiber-to-the-home internet to the Deadwood community. Pioneer Connect is working together with the schools (Triangle Lake and Mapleton) and the community to address issues and concerns in our area.

This project will help our children fully participate in distance learning (as well as provide internet access for school work and other educational opportunities postpandemic), expand the reach of the farms and other small businesses we run, make it possible for us to work from home, and improve the access to health care for everyone (particularly senior citizens) through telehealth services by making it easier to meet with our health care providers. The project may also support High Speed Internet at the Community Center.

Pioneer Connect has served this area for decades. They have reached out to the community seeking support for their grant application. This grant program has limited funding and is competitive with funds only going to the highest scoring applications. Community support accounts for 40% of the scoring. How the grant addresses educational challenges, health needs, and public safety issues and the economic characteristics account for 50% of the scoring. Management experience accounts for the remaining 10%. Pioneer's outreach letter of November 9 describing the program is posted our community's Facebook page. We encourage you to read it, ask any questions you may have, and indicate your support by sending your comments about how having high speed

internet will impact these challenges to <u>CommunityConnect2020@pioneerconnect.</u> net.

This project will enable our community, our children and our businesses to remain safe, healthy, vibrant and thrive so that we can continue to enjoy life in the Deadwood area that we love so dearly.

#### Trees, Trees, Trees

The Siuslaw Watershed Council (SWC) gives away thousands of free native plants annually to community members throughout the Siuslaw and Coastal Lakes Watersheds. If you have a creek flowing through your back yard, or live along one of our scenic lakes, you may be eligible to receive free native plants next February from SWC.

Natives plants help clean the air, clean the water, and create habitat for wildlife. We based the choices on feedback from our community: pollinators, coastal forbs, and uncommon plants that were once more abundant.

SWC staff can help with your plant list and our field technicians can help prepare your site, plant seedlings, and maintain the site. Visit our website at www.siuslaw.org and click the 'Engage' tab to find the "NPD Brochure" and "Place Orders" links.

Your free native plants will be available for pick up on Saturday, February 6, 2021 at multiple locations throughout the area. COVID safety measures will be in place this year, which may include picking up by appointment. We will follow current guidelines and communicate safety measures in advance. Support for NPD comes from the Coast Range Stewardship Fund, Three Rivers Foundation, and Operation Appleseed.
