Check with Nancy to see if you owe money or have a credit.



DEADWOOD COMMUNITY CENTER RENTAL FEES FOR COMMUNITY MEMBERS

Community shall be defined as residents of Deadwood, Swisshome, Nelson Mountain Rd, and Greenleaf.

Community Rental Fees are as followers:

For up to 6hrs:

6 - 12hrs:

0-30 people \$20.00

30-60 people \$60.00

0-40 people \$40.00

30-60 people \$120.00

Rental fees and use of DCC by more than 60 people must be approved of by the building coordinator prior to use.

Any rental shall require the payment of a cleaning deposit, in the amount of \$100.00, which may be used and is non refundable in the event that the community center is not left clean and neat as required per the clean up list in the kitchen. Within 7 days of use the deposit shall be returned upon the coordinator determining that DCC was left clean and neat as found. Any and all cost to clean the community center as it was when rented, shall be deducted from the clean up deposit.

DEADWOOD COMMUNITY CENTER USE GUIDELINES

THE USE OF THE COMMUNITY CENTER IS FOR THE GOOD OF ALL

BUILDING USE GUIDELINES

The use of the Deadwood Community Center (DCC) is scheduled on a first come first serve basis.

Reservations are required. Any use of the DCC shall require a written reservation signed by the Building Coordinator (BC) and Building User (BU). Reservations are not finalized until signed release form and hold harmless agreements are completed and signed by BU and BC, and all fees are paid as is applicable.

Rental fees for use shall be per the written rental agreement between Deadwood Creek Services (DCS) and BU.

No alcohol may be sold at the Deadwood Community Center No drinking by minors will be permitted. Chaperones will be required for events with minors.

No smoking of anything in the Community Center. Smoking is only allowed on outside decks and outside surrounding areas. Please use ash cans provided to extinguish smoking material.

Basic cleanup is the responsibility of the BU. Leave the Center as clean you found it.

All garbage and recycling/returnables must be removed.

Attached is a list of clean up procedures, which shall also be posted in the kitchen area.

Use of the facility includes the time needed for preparation, setup and cleanup of an event. Cleanup must be completed immediately after the event is over. Cleaning deposit may be required at discretion of the BC. Rental fees include any time that prevents others from using the facility as a result of BU delays in and or cleanup.

An event of more than 40 people may require the BU's to rent a porta-potty per the discretion of the BC.

No internet service is available.

For Medical and Fire emergencies at DCC please call 911. The phone is on the counter by the back door in the kitchen.

Rental and Hold Harmless

Agreements are required when the DCC is rented.

BU will need to bring their own firewood for heating. There is no other source of heat at DCC.

Any use of outdoor fire pit requires special arrangement with BC.

It is acknowledged that the Kitchen Gas Range is not available for use unless there is prior written approval by BC except with the prior arrangement with the BC.

Deadwood Creek Services the governing board of DCC reserves the right to determine appropriate use of the Deadwood Community Center. DCS reserves the right to refuse use of the DCC to any party at its sole discretion.

There are no OVERNIGHTS or Camping AT DCC except with the prior written consent of BC which includes a release of liability and hold harmless agreement as is appropriate.

Rental fees for use shall be per a written rental agreement between DCS and user.

Any and all of the lighting at DCC including decorative lighting, is to stay in place and is not to be moved. Use of lighting shall be explained by BC.

DCS - Deadwood Creek Services (Organization and Board for the DCC)

The use of DCC includes the following:

1) All kitchen utensils, dishes, refrigerator, spices, tea and other items in the kitchen. There is no obligation by DCC to provide any of the above. 2) Folding tables and chairs are provided and to be returned where found. 3) Water, 4) flush toilet and reasonable amount of toilet paper and paper towels. Other than the above the user is responsible for their own supplies, food, firewood, as is necessary, per their specific needs.

My sister, Sherry Lyn McNutt, passed away recently on the morning after her 75th birthday. She made a great impression on me as the older sister who seemed she knew everything- or at least, let me believe that! She was a specialist and teacher in geophysics and had a hand in developing and using the first LandSat data. At one point she was in charge of the European Space Agency for Canada and hosting official international conferences on Climate Change, etc, and later was a professor at the University of Alaska, focusing on sea ice. She was also an artist, and, early on, she was at a crossroads as to whether to work as an animator for Disney or going to work for Jet Propulsion Laboratories (JPL) and chose JPL because Disney had a dress code. That was a fork in the road which changed her life.

She also was a DJ on about 5 radio stations over the last 40+ years, was well informed musically and had a collexion of over 15,000 CDs, which were a part of her last program (on KKCR, in Kauai), called "The Omnitorium".

I received lots of hand me downs over the years, especially clothes and music.

She lived in Deadwood one summer briefly (2005) renting a cabin at Cindy Forslev's at the same time Kaki & Billy were landing there. This anomaly occurred because she asked my Astrological advice on when she should put our parents' house up for sale after my mother's passing and I replied that it would sell quickly if on a certain date and time- and the house sold in minutes, giving her little time to deal with details and the next chapter of life.


I recently went back to my natal home in NJ, which my dad had built and where we last lived together, much changed but still the yard was full of memories.

The New Curmudgeon

The hokey pokey...that's what it's all about.

Things are not as easy as they used to be. Decisions, now clouded by the complexity of our culture, struggle for the light of solution, but there is only the reflection in a mirror. The fundamental challenge of the brain is to solve the problem of uncertainty. Nothing we see is the truth. We agree on stuff because we all have the same interface that creates the illusion of reality. Counterconstancy is the term used to describe a situation where people can see the same thing differently, sometimes at the blink of the eye. The brain struggles to make something useful out of any stimulus. We are constructing our reality as we go. Evolution has hidden any objective reality we might experience. Everything we perceive is evolved to keep us alive...yet 99.9% of all species that have ever been on this planet are now extinct. A prior influence alters the speed of perception and perception is a continual cycle of error correction. It's always expectations vs evidence. It is said that perception is a controlled hallucination. Understanding perceptions is the key to conflict resolution. Entering a conflict is the way we learn. We are developmentally denied the natural acquisition of but a tiny speck of the limitless range of vibratory phenomena, a tiny band between red and violet, blind to all between, from radio and cosmic rays, and to ultraviolet, where many other species excel.

Rilke was right- humans will take the easy way and as we evolved we learned to survive by taking the easy way even if it ignored the true reality. But evolution is not the simple story of natural selection...not the whole story. There's genetic drift and linkage plyotrophy to complicate things. Now quantum theory says that space-time is only a function of the headset. Maybe we all suffer from a form of mental anosognosia. We have joined the caravan, you might say, at a certain point, we will travel as far as we can, but we cannot, in one lifetime see all that we would like to see or learn all that we hunger to know. As we stand on this

circumscribed pinpoint of time, our sight for the past is growing longer and even the shadowy forms of galactic future becoming more clear. Yet our own fate we cannot see. We live in the news cycle of a perpetual present. "If the universe is meaningless, so is the statement that it is so, for the meaning and purpose of dancing is the dance". *Alan Watts*. To make meaning out of indifferent fact must be the supreme reward of consciousness. "Atoms with consciousness...matter with curiosity". If we are not careful with the momentum of our minds we can live out our days in the near-life existence of waiting for some form of deliverance from the uncertainty raging outside the frosted windows of the here and now. when time forecloses possibility, as time always ultimately does, it is no failure to have been less than or more than.
